6. Rotten sleeper to be replaced. **Complete**
7. **a)** Sign on gate to warn of cyclists/pedestrians. **Complete** **b)** Directional sign to 8th tee, probably sited on tree to right of 7th green. **Complete** **c)** Anti-slip surface on Ladies tee needs replacing. **To check**
8. Clean steps. **Complete**
10. Widen bridge with sleeper both sides? *deemed unnecessary*
12. Decision on priority to 13th tee – cars or golfers? possible ‘zebra crossing’? (Previous suggestion not actioned?) **Ongoing**
14. Tall flag - 9’ - visible from the tee for those attempting to drive the green. **Complete**
15. Barrier to be put at top of steps – *deemed unnecessary*. Warning sign needed - *deemed unnecessary*.
